

Round2 Question for Review Effectiveness of Awareness – Malay

1. Anda telah menerima panggilan telefon daripada pihak polis kerana terlibat dalam kes penggubahan wang haram. Untuk makluman, pihak Agrobank juga tidak lagi menghantar sebarang pautan laman sesawang melalui SMS bagi apa jua tujuan termasuk promosi dan kempen.

Jawapan: b

Phase 2 Question For Review Effectiveness of Awareness – English

1. You received a phone call from a police officer and claimed that you were involved in money laundering. You were then instructed to lodge a police report over the phone and transfer some money or assets to a temporary account for them to investigate further, and with the money being returned once the investigation is concluded. What will you do?

- a) Continue the conversation, lodge a police report over the phone call and pay the penalty charges in view of money laundering is a serious criminal offence.
- b) Immediately end the phone conversation.

Answer: a
