### 1.0 Interface Overview Description

The objective of this integration is to enable employers to perform EPF payments and Form A submission thru bank. Before an employer is eligible to submit Form A electronically, a series of test is carried out by EPF on the Form A test data. If the testing result satisfies EPF guidelines and procedures, the employer will be enrolled as eligible to submit Form A electronically. Notices will be sent to inform employer(s) on the result of the testing and corrective action if there is any. An outgoing interface file will be generated to inform bank the testing results.

Beside Form A payment, the following are the new payment type that bank should provide:

1. Self-Contribution (Self Employed or i-Saraan / i-Suri ).
2. Form F payment. Arrears of Form A. Employers must state the Form F reference number.
3. Late Payment Charge. Late Payment Charge being imposed by employers for making late contribution for employee.
4. Dividend. Employer compensation to employee(s) for dividend loss due to late contribution.
5. Other Charge. Fee for manual processing of Form A and submission of incomplete employee data in Form A will be grouped as other charge.

For payment type 3, 4, and 5, the employer will be informed the payment details like amount and due month by EPF via mail.

The files transmission should be via EPF Third Party Middleware – PAYMATE system.

The PAYMATE system is in place to ensure better security and control over the data and file, preventing duplicates files, loss of data, invalid data with encryption. With this system, all files transmission are automated between the PAYMATE server and PAYMATE Agent. Participating bank is required to open port and provide a dedicated PC to installed the PAYMATE agent

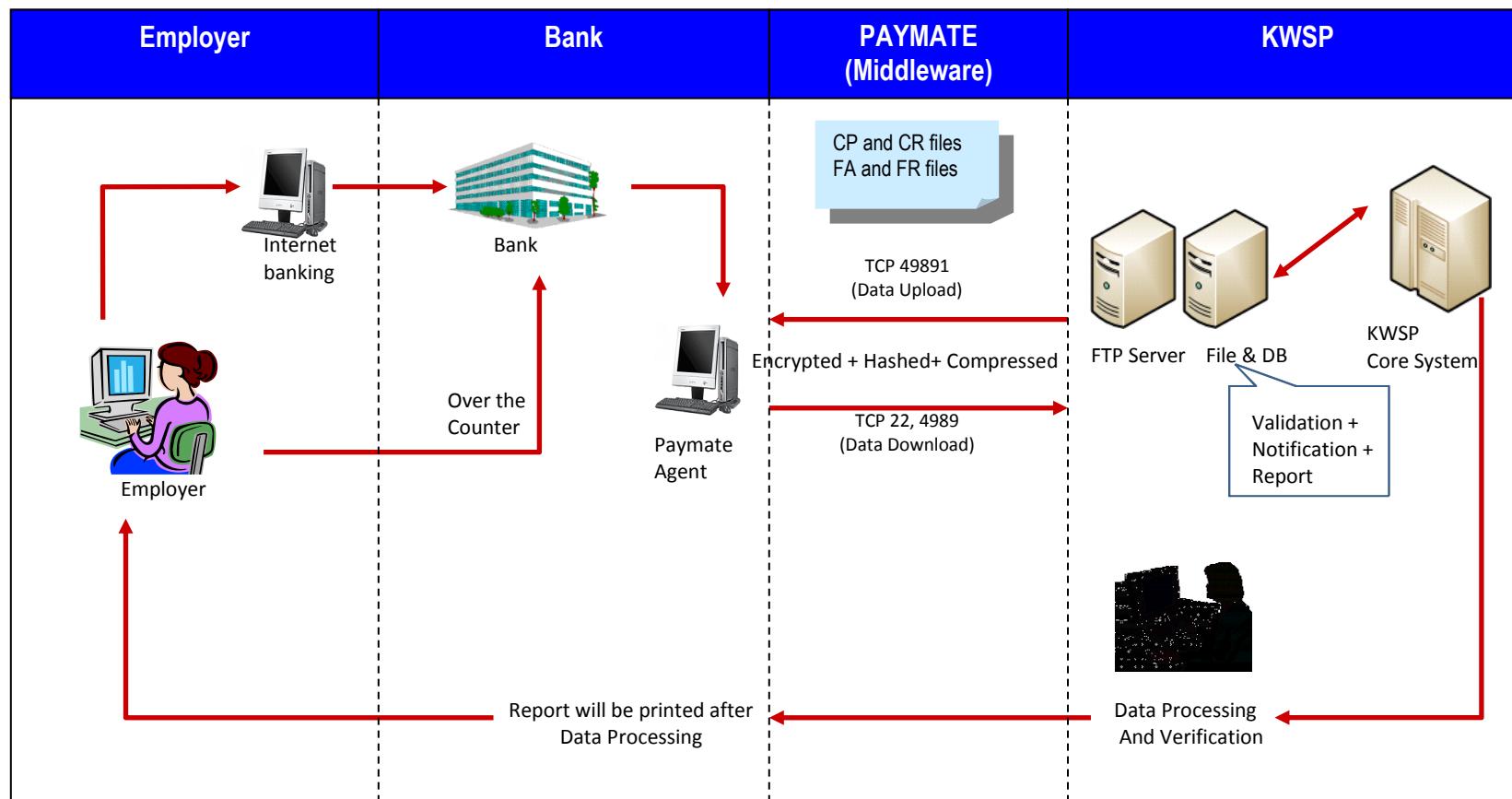

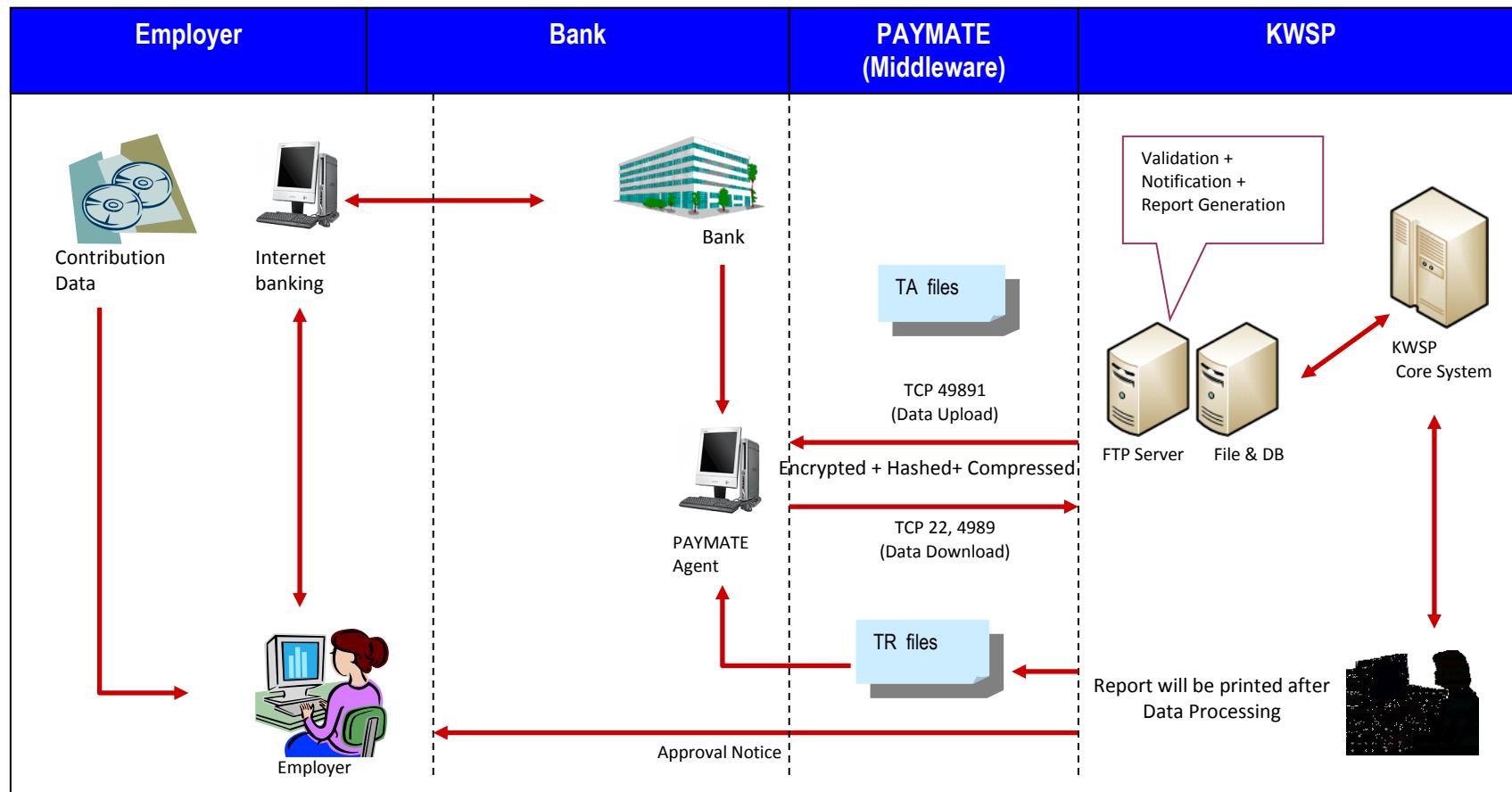

### 4.0 File Transfer Protocol

- a. From Bank to EPF.

The interface file and report file are transferred from bank to EPF via EPF Third Party Middleware – PAYMATE system . Participating Bank are required to:

- i) Open Port 49891 to enable data upload.
- ii) Provide PC to installed the PAYMATE agent that transmit the files from/to EPF PAYMATE Server.

All file transmission are automated between the PAYMATE server and PAYMATE Agent Please refer to Appendix 13.1.

- b. From Bank PC (at EPF) to ISERIES.

The incoming interface file will be loaded into ISERIES via FTP. This can be done automatically at SiPFS Core System by retrieving the interface file from the PC folder. The system shall monitor the PC folder at predefined time for any new interface file

### 5.0 Processing Rule

#### 5.1 Selection Criteria (for batch extraction)

Bank shall follow the following selection criteria.

- a. EPF Payment Collected at Bank.
  - i. Select all EPF payment collected at bank counter and internet facility and output into interface file. This includes cheque, FPX (for MBB only), EFT (for RHB only), CDM (for PBB only) or cash payment.
  - ii. Cheque clearing status. If the cheque is dishonoured the information shall be forwarded to EPF for payment status update.
  - iii. The EPF payment details must be tallied with the Form A data in terms of amount and employer number.
  - iv. The payment types to be collected at bank are as follows:
    1. Form A Contribution. Must be accompanied by Form A details.
    2. Self-Contributions. (Self Employed or i-Saraan / i-Suri). For self-contribution payment the EPF doesn't require Form A.
    3. Form F payment.
    4. Late Payment Charge. Late Payment Charge being imposed by employers for making late contribution for employee.
    5. Dividend Loss. Employer compensation to employee(s) for dividend loss due to late contribution.
    6. Other Charge. Fee for manual processing of Form A and submission of incomplete employee data in Form A will be grouped as other charge.
    7. i-Saraan / i-Suri contribution.
- b. Employer's Form A submission.
  - i. The employer must be given approval by EPF before submitting the Form A via internet banking.
  - ii. The Form A data must be tallied with payment details in terms of amount and employer number.

### 5.2 File Processing Rule

The following is the processing rule that EPF will perform on the incoming file.

EPF payment collected at bank.

- i. Header record:
  1. The bank code and state code must be valid.
  2. Transaction date must be current date.
- ii. Detail record:
  1. The bank code, state code, payment mode and code must be valid as in item 6.0.
  2. The employer/member number must be valid.
- iii. Trailer record:
  1. Total number of payments and amount must match with record type '01' and '02'.
  2. The hash total is equal to total member EPF number.
  3. Based on the EPF payment collected at bank control summary report, the system will check the total number payment and amount against the values in the interface file trailer record.

The header and trailer record is repeated by bank code and state code. The interface file detail portion will be grouped by bank code and state code.

b. Form A submission.

- i. Header record type 1.
  1. The processing date must be current processing date.
  2. The running sequence number must be unique. The system will log the file header record type 1 details – processing date and sequence number, for tracking purpose. The system will not process the file if there is duplicate entry.
  3. The testing mode indicator is used to determine whether the interface file content is meant for posting or testing.
  4. This is control record format for interface file. Each interface file will have one header record format type 1.

- ii. Header record type 2.
    - 1. This is control record format for employer. Each employer will have one header record type 2.
    - 2. Employer must indicate whether Form A contribution is new or supplementary follow by contribution sequence number.
    - 3. The transaction date must be equal to transaction date in payment file (credit advice).
  - iii. Detail record.
    - 1. The validation of the detail record will be done at Contribution Module.
  - iv. Trailer record.
    - 1. Each employer will have one trailer record.
    - 2. The payment amount fields must be matched with payment file (Credit advice.)
    - 3. The total fields must be equal to total of detail record fields.

The system will ensure that the interface file will not be processed twice. This can be done by verifying the file name. The interface file name must have prefix which is equal to current date. Processed file will be tracked and logged into the system.

### 5.3 Formula

Hash total = total member/Employer EPF number.

### 5.4 Reconciliation Method

The following are the reconciliation procedure:

- i. Payment Collection.

The trailer total will be checked against EPF Payment Collected at Bank Control Summary Report ('CR' + bank code + DDMMYY+HHMMSS).
- ii. Form A submission.
  - a. The trailer total for each employer will be checked against Form A Submission Control Report 'FR' + bank code + DDMMYY + HHMMSS.
  - b. The trailer total will be checked against credit advice interface file detail for corresponding employer payment.

**10.0 Security**

Outgoing / Incoming file to/from Participating bank will be transmitted thru PAYMATE system (Third party Middleware) with the following features:

- i Encryption: All files will be encrypt using Advance Encryption Standard algorithm (AES-256)
- ii Hashing: All files will be hashed using Secure Hash Algorithm (SHA-256) to enhance integrity of the files
- iii Compressed: All files will be compressed for more efficient transmission (70 – 80% compression ratio using DEFLATE algorithm)
- iv Constant communication between Agent and Server to ensure file delivery
- v Audit Trail of all file transmission
- vi Instant notification via email in case of communication problems

**11.0 Exceptional Handling**

If the interface file data is incomplete or inconsistent or the line is disconnected, JTM shall inform the bank within 24 hours. Bank should respond with the corrected data within 24 hours.

**13.0 Form A Submission Testing**

This section shall discuss the process of obtaining approval for Form A submission via internet banking.

Below is the procedure:

Employer(s) intend to submit Form A via internet banking shall first send testing data to EPF for verification. EPF will perform the following:

- i. Verify the interface file format. The interface file format must be correct and conformed to EPF standard file format as in item 2.1.2, 2.13 and 2.14.
- ii. The detail content must be correct in term of employee name, ID number and the employer and employee contribution must be within EPF contribution schedule. The total number of employee for each employer must be correct. If the information send by employers is incorrect, EPF will generate notice and report to inform employers the testing result and corrective action(s). Refer to item 9.6, 9.7 and 9.8 for the notice and report format. Bank will receive a copy of the same notice above.
- iii. In addition to notice(s) above EPF will inform bank the status of the testing electronically via an outgoing interface file to bank. Refer to item 2.3 for interface file format.

- iv. If the interface file format is correct and the rate of error(s) is <= 5%, automatic approval will be given to employers. Approval notice (refer to item 10.5 for the format) will be mailed to employer(s) and bank. For testing error(s) which is > 5%, the system will provide user interface screen to manually approve the application.

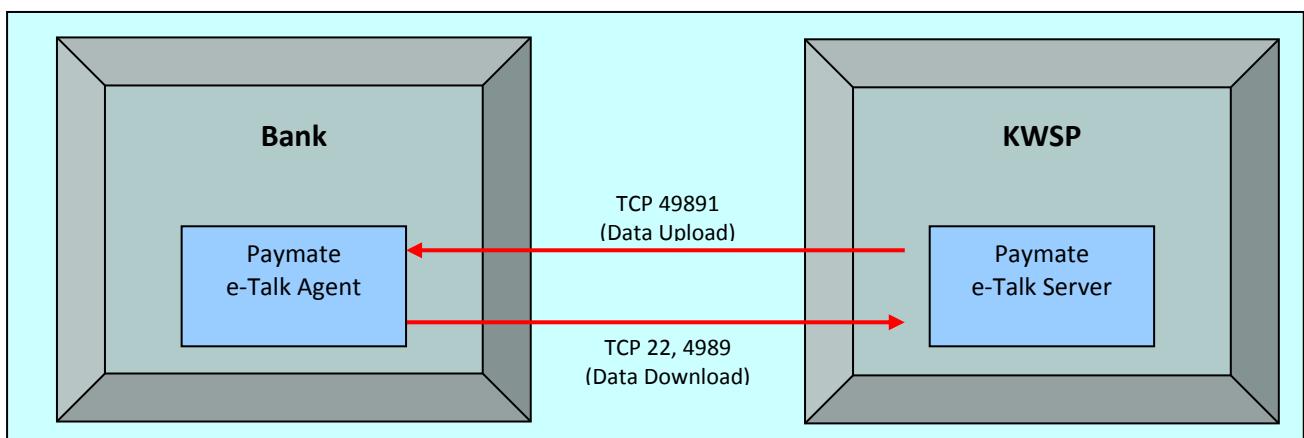
